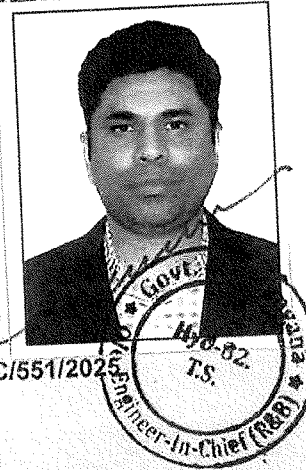

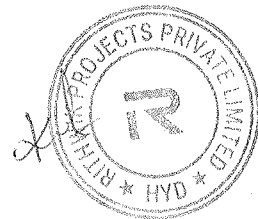
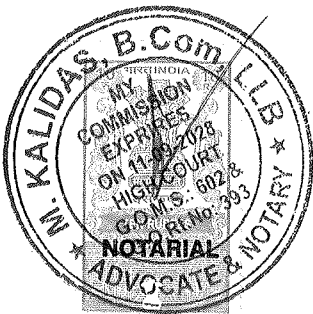

CONDITIONS

1) Demotion of Contractors:

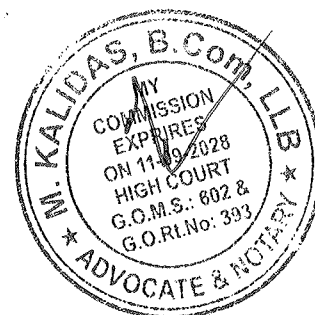
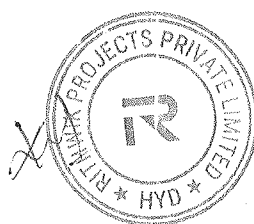
The registering authority may demote a contractor to a lower class if he :

- i) fails to execute contractor or executes it unsatisfactorily or is proved to be responsible for constructional defects.
- ii) has no longer adequate equipment, technical personnel or financial resources.
- iii) violates any important conditions of contract.
- iv) is responsible for any other matter which may justify his demotion to a lower class.
- v) if litigious by nature.

2) Removal from the approved List:

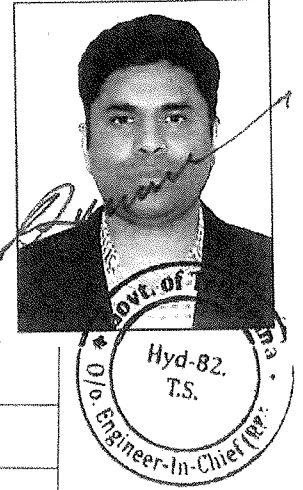
Registering authority may remove the name of a contractor from the approved list, if the contractor:

- i) has on more than one occasion failed to execute a contract or has executed it unsatisfactorily.
- ii) fails to abide by the conditions of registration or is found to have given false particulars or information at the time of registration.
- iii) Persistently violates any important condition(s) of the contract.
- iv) Is proved to be responsible for construction defects in a number of
- v) Is declared or in the process of being declared bankrupt in solvents wound up dissolved or partitioned.
- vi) Persistently violates the labour regulations and rules.
